Report:

Background:

On November 5, 2020, the Province of Ontario released <u>Bill 229: Protect, Support and Recover from COVID-19</u> <u>Act (Budget Measures), 2020</u>. The Bill is being proposed to implement Budget measures and to enact, amend, and repeal various statutes.

Bill 229 will affect a significant number of Acts, including the *Conservation Authorities Act* (identified as Schedule 6 in Bill 229). The amendments deal with matters such as membership; objects, powers and duties of the Conservation Authority; fees; land use planning; and enforcement.

The changes could require that a member of the Conservation Authority be a municipal councillor (with the Minister able to appoint a representative from the agricultural sector). The legislation also limits the objective of the Conservation Authority to matters prescribed by regulation and would require Conservation Authorities to enter into an Agreement with municipalities if municipal funding will be required. The Conservation Authority is still permitted to set fees and issue permits, but the fees and permits could be appealed to an administrative tribunal. Finally, a provision that had not yet been declared into force allowing Conservation Authorities to issue stop work orders has now been repealed such that the Conversation Authorities will not have this ability.

Analysis:

Bill 229 received First Reading on November 5, 2020 and has begun Second Reading throughout November 2020. As of November 23, 2020, Bill 229 was referred to the Standing Committee on Finance and Economic Affairs pursuant to the order of the House. At the time of writing this report, the Bill is still under the status of Consideration of a Bill by the Standing Committee.

Staff have attached correspondence from the Association of Municipalities of Ontario, the Ontario Federation of Agriculture, and documentation from the Chair of the Saugeen Valley Conservation Authority regarding Bill 229's impact on Conservation Authorities for further consideration.
