Recommendation:

That the Council of the Municipality of Brockton hereby receives Report Number BCCC2020-08 – Brockton Child Care Centre Fee Increase, prepared by Sharon Bross, Brockton Child Care Centre Supervisor and in doing so approves an increase of one dollar (\$1.00) to all parent fees effective January 1, 2021.

Report:

Background:

The Brockton Child Care Centre continues to be an essential service for the families within the community which has become increasingly more evident as a result of the COVID-19 pandemic. The Brockton Child Care Centre's only revenue sources are through parent fees, County and Government grants, and a small portion subsidized though the tax rate for the new facility.

In 2020 fees were not increased as staff at the Brockton Child Care Centre originally forecasted revenue for the expansion of the Centre based on pre-Covid capacity. While the expansion is exciting for the future, the Brockton Child Care Centre cannot increase enrolment to the maximum capacity of the centre as expected at this time because of the covid-19 related limitations. These limitations have resulted in fewer children able to attend because of the room space limitations, need to cohort and additional staffing costs to screen families and ensure there is a "runner" to escort children to their parents.

Analysis:

As a result, the Brockton Child Care Centre will need to increase revenue to continue to fund operations into 2021. Staff are proposing that the user fees paid for the programs at the Brockton Child Care Centre increase by \$1.00 per program to raise \$49, 130.00 to off-set increases to the tax rate (\$49,130.00 represents approximately 0.5% percent tax rate increase). The proposal is to begin charging the new fee as of January 1, 2020 and the revised Fees and Charges By-law has been brought forward for Council's consideration, as raised with the Brockton Child Care Centre Committee at the meetings on October 20, 2020 and December 1, 2020.

Staff continue to work closely with the County of Bruce for financial support as required and investigate Provincial funding as announced.


