#### **Recommendation:**

That the Council of the Municipality of Brockton hereby receives Report Number PW2018-25 - Sidewalk Snow Removal Options, prepared by John Strader, Roads Supervisor, for information purposes and provides further direction to staff on the preferred option.

### Report:

#### **Background:**

At the November 5, 2018 meeting, Council was presented with Report Number PW2018-24 - 2018 Sidewalk Snow Removal for the Villages of Chepstow, Cargill and Elmwood Tender,. As per Council's request this report serves as a follow up as staff has reviewed further options.

#### **Analysis**:

Staff has been contacted by two interested individuals, however after a more in depth discussion of the requirements the individuals decided as they were from out of town, and the distance between the hamlets and the size of the job was not practical for them to take on. Staff also reached out to the two individuals whose names were provided by Councillor Adams. The first individual did not have time to have the sidewalks cleared by 7:00 a.m. and the second individual was not interested. Supplying the proper equipment to limit property damage was an issue for both.

Staff has reviewed the following three options:

#### Option 1) Purchase snow removal equipment and hire staff

A quote for \$150,000 for the necessary snow removal equipment has been received from an equipment supplier. This equipment purchase would be funded by the Municipality of Brockton Equipment Reserve over a ten year period (\$15,000 a year).

Furthermore, it would be necessary for the Municipality of Brockton to hire a seasonal operator for an approximate cost of \$40,000 (salary and benefits). The annual operating cost is estimated to be \$65,000 for maintenance and fuel of the purchased equipment, extra salt and sand as required for the Hamlets of Chepstow, Cargill and Elmwood, as well as a truck and trailer to haul the equipment.

### Option 2) Continue with the Municipality of Brockton current maintenance practices

Currently the Municipality of Brockton closes sidewalks in the Hamlets of Chepstow, Cargill and Elmwood, making it difficult for the pedestrians of the hamlets to walk safely in areas. If the Municipality of Brockton continues with this practice, staff will mark all closed sidewalks and ensure residents are aware that the Municipality will be proceeding with this practice.

#### **Option 3) Implement Snow Removal Policy or By-law**

Staff has researched other municipalities Winter Sidewalk Maintenance policies and By-laws as an option to implement a practice within the Municipality of Brockton.

Municipalities have passed By-laws where the municipality is responsible for snow maintenance in front of all Municipal owned property. All other sidewalks are maintained throughout the winter by property owners with sidewalk in front or beside their property. This course of action may be more effective in larger cities where properties are smaller and snow fall is more easily managed.

We seek Council's direction to move forward based on the options presented.
