Report:

Background:

In 2020 the Municipality of Brockton levied \$9,683,265 in municipal taxes, this was an increase of 9.77% over the 2019 levy, and this resulted in an annual increase to the average household of \$170.65.

Analysis:

This report is to provide Council with additional information on the Property Tax Arrears for the year ending December 31, 2020. Each year the municipality reports their financial position to the Province, below is a chart that illustrates the Provincial standards on Tax Arrears:

At the end of 2020, the overall outstanding tax arrears were \$509,276.24 (excluding accumulated interest). However, the total uncollected for 2020 taxes equals \$373,300.82 which equals a total of 3.86% of the 2020 Municipal Tax Levy. While 2020 was a difficult year due to the COVID-19 pandemic, the total outstanding taxes at the end of 2020 dropped compared to prior years. The chart below will illustrate the changes from 2016 – 2020:

Due to Covid-19, staff did not commence any new properties for the Tax Sale Process. Staff continue to work with residents to ensure their account remains in good standing.

Listed below are a few of the various tools that are utilized by staff throughout the year to collect tax arrears:

- Send tax arrears notices (monthly)
- Make calls to those who are within the two three-year arrears time frame
- Make payment arrangements to accommodate paying current year taxes, as well as any arrears balance

With the Municipality of Brockton having 3.86% outstanding Tax Arrears at year-end, we are below the Provincial low-risk average of < 10%. Therefore, this low average indicates that residents are able to pay their taxes, the Municipality has adequate tax collection procedures and low risk to cash flow issues.
