

Memorandum of Understanding (MOU)

Between

Bruce Power

and

Municipality of Brockton

with respect to the

Brockton Regional Fire Training Centre

Effective Mar 24, 2021

BACKGROUND

The Ontario Fire College (OFC) has restructured its format and moving to a regional approach and as such the Municipality of Brockton has entered into a memorandum of understanding with the Ontario Fire College with the goal of providing Brockton and its surrounding regional fire departments with affordable, attainable and accessible training in a safe, professional environment.

A portion of certain courses the Brockton Regional Fire Training Centre intends to offer a live fire aspect in the training. The Brockton Regional Training Centre is therefore entering into this agreement with Bruce Power, whereby Bruce Power supports the live fire aspects of these courses by allowing students of the Brockton Regional Training Centre to attend and train at the Bruce Power Fire Training Facility.

PURPOSE

- 1) The purpose of the MOU is to formalize the partnership between Bruce Power and Municipality of Brockton with respect to the Brockton Regional Fire Training Centre. Bruce Power will support the live fire aspects of these courses by allowing students of the Brockton Regional Training Centre to attend and train at the Bruce Power Fire Training Facility including the use of the facilities, props and equipment as well as manpower to run the props for training scenarios.
- 2) Brockton Regional Fire Training Centre will identify skills-based program training requirements to Bruce Power EPS Fire Management personnel with as much advance notice as possible in order to schedule these sessions in a flexible manner to the mutual benefit of all parties.

- 3) Use of Bruce Power's Fire Training Facility will be subject to the terms and conditions set out in the "Fire Training Facility Rental Agreement."
- a) As per the agreement, participants will ensure that prior to arrival on site, they will provide Bruce Power with WSIB clearance certificates,
 - b) Together with a list of workers' compensation registration numbers (see section 4.3 of the agreement).
 - c) Also provide a certificate of insurance (see section 6.2 of the agreement)

TERM

The MOU ends December 31, 2022.

The parties may choose to review the Terms of this MOU at the anniversary date and make any amendments as required and as mutually agreed by both parties.
