#### 7.2 Riversdale Bridge Environmental Assessment Option 3 Decision

Gregory Furtney, Director of Operations, responded to questions from Council and confirmed that there were limited grant opportunities, regardless of whether a one or two lane bridge was selected. Council discussed the additional safety benefits of a two lane bridge as needing to be balanced against the significant cost difference. Mr. Furtney confirmed that discussions that had occurred with the municipal engineers and the County of Bruce with respect to the potential need to redirect traffic in the future. Mr. Furtney confirmed that if updated pricing comes back significantly higher in the future, the Municipality of Brockton could revert to a one lane bridge if required.

Council discussed the benefits of extending the sidewalk to the Elmwood Community Centre to improve safety along that corridor and recognize the Centre as a community hub. Gregory Furtney, Director of Operations, explained the engineering challenges that would result in the sidewalk buttressing the new road without an additional boulevard. John Strader, Road Supervisor, responded to questions from Council about the challenges of larger shoulders and the snow-clearing plan for the proposed sidewalks. Council approved the sidewalk extension to the Elmwood Community Centre.
