Background:

The following summary of activities and updates from past 2 months is provided for Council's information an outlines expected opening dates:

COVID-19 Response

- Update COVID Safety and Operational Plans as regulations change.

Programs

- Monthly virtual programming.

- Swimming lesson and day camp programs planning and scheduling registration opens May 25.
- Day Camp scheduled to start June 29th.
- Day Camp Storage Building 8x12 weather proof/vandal resistant for Centennial Park ordered.
- Canada Day virtual programming consultations underway.

Walkerton Community Centre/Arena Operations

- Ice removal and seasonal shutdown/maintenance of refrigeration plant.
- Infrared scan of electrical panels emergency repairs.
- Annual Asbestos Management Program inspections.

Parks Operations

- Seasonal opening of Durham St Park and Cunningham Rotary Nature Park.
- Turning on of fountain and cleanup of Heritage Water Garden in cooperation with volunteers.
- Community Gardens spring cleanup, composting and tilling.
- Hazard trees removal and cleanup of Lobies Park.
- Playgrounds inspections of all Brockton playgrounds and repairs to Glammis and Elmwood Lions Park units.
- Flower beds cleanout, weeding and tilling throughout Walkerton.
- Grass cutting equipment servicing and cutting of properties began April 26th.

- Tree and shrub planting (50 to date) along Saugeen River Trail, Lobies Park and Cargill CC.
- Monitoring and removal of Hogweed ongoing.
- Centennial Park rain garden installation site preparations.
- Hanging baskets and planter installations scheduled for week of May 31 including Elmwood and Cargill.
- Weekly Saugeen River access point checks and garbage collection.
- Opening of Lobies Park Campground scheduled for mid-June. (Provincial reopening plan).
- Tennis and basket ball courts, pavillions reopening May long weekend (Provincial reopening plan).

Trails Operations

- Saugeen River Trail spring grooming.
- Removal of graffiti on Truax dam wing wall.
- Hazard tree removal and trimming completed from Yonge St., bridge to River Bend Park.

Pool/Splash Pad Operations

- RFQ's for pool roof resurfacing and boiler heater replacement.
- Plumbing repairs and installation of outdoor showers.
- Splash Pad setup and opening scheduled for mid-June. (Provincial reopening plan)
- Pool basin pump out and power washing in preparation for fill and opening June 25th.

Soccer Fields/Ball Diamonds Operations

• Rolling, aerating, irrigation system start-up.

Cargill Community Centre Operations

- Facility remains closed.
- Zero turn 72" lawn tractor replacement per budget.
- Pickle Ball programming between 2nd and 3rd wave lockdowns.
- Discussions to support Cargill Lawn Bowling Club and agreement renewal.
- Ball diamond grooming

Bradley School House Community Centre Operations

- Facility remains closed.
- Failed well water pump and pressure tank replacement and frequent checks.

Elmwood Community Centre Operations

- Facility remains closed.
- Board continues to meet by Zoom planning capital budget work, exploring grant opportunities and discussion on making community centre a "Community Hub".
- Removal of ball diamond dugout shelters damaged in November wind storm.

Community Beautification

- Touch base with community representatives in Elmwood, Cargill and Chepstow regarding use of funds to support community beautification. Elmwood doing 20 additional planters. Chepstow is doing planters after bridge rehabilitation.
- Reached out Walkerton BIA regarding beautification ideas for highway welcome sign gardens and downtown seasonal décor.
